

# Accorhotels.com 'Find your Summer' competition - Terms and Conditions

1. These terms and conditions apply to the Accorhotels.com "Find your Summer" promotion. The promotion commences 9:00am November 4 2016 and ends midnight December 11 2016 ("**Promotional Period**"). This promotion is conducted by AAPC Properties Pty Limited.
2. Entry into the promotion is deemed acceptance of these terms and conditions.
3. Any decision of AAPC Properties Pty Limited will be final and no correspondence will be entered into.
4. Participation in the promotion is open to participants who register and complete the required details on the Accorhotels-closerthanyouthink.co.nz "Find your Summer" promotional entry form during the Promotional Period. Incomplete, indecipherable or ineligible entries will not be accepted and will be deemed invalid. All entries become the property of AAPC Properties Pty Limited.
5. Entrants are limited to one entry per person. Entries are deemed to have been received at the time of receipt by AAPC Properties Pty Limited. AAPC Properties Pty Limited's records will be final and conclusive as to the time of receipt of an entry.
6. AAPC Properties Pty Limited reserves the right to verify an entrant's identity, age and place of residence.
